

## End User License Agreement (“EULA”)

Product: “Green Pepper PRO” (Disk erasing software)      Version: 4  
License:                    **Single-User License**  
Validity period:        1-Year

This End User License Agreement (“EULA”) is a binding legal agreement between you (“You”), as an individual or entity, and Kirara21 Co., Ltd. (“Kirara21” or “We”), for the use of this Software (“Software”).

### 1. Delivery of the Product

The product will be provided by online download via the Internet. Follow the install/creation procedure and install or create a CD-ROM (CD-R) on your personal computer (“PC”) by yourself.

### 2. Grant of license and limitations

Licensor hereby grants to Licensee a non-exclusive license to use a copy of the Software.

- You can make one back-up copy of the Software.
- You can install (copy) Windows execution programs on only one PC. If you want to execute them on another PC, you need to delete them from the previously used PC.  
The CD-ROM(CD-R) media/USB flash drive created/configured by the Software function for erasing execution is always limited to one copy. If you use different media/USB flash drive, you need to discard / erase the previously used one. Also, you cannot copy the created media.
- You can hold different types of erasing media (CD-ROM, USB flash drive), erasing program (include Windows executable) at the same time. However, you cannot use them separately, cannot place them separately in different locations, and erasing different PCs at the same time.
- There are no restrictions on the number of PCs to be erased or the number of times to be used. However, it is not possible to erase multiple PCs at the same time.  
This software can be used to erase PCs owned or managed by you. It cannot be used for PCs not owned or managed by you, such as for commercial purposes.
- You may not reverse engineer, decompile, or disassemble the Software.  
You can transfer the Software if the recipient agrees to this EULA. In that case, you will not be able to retain the copy of the software. In addition, when transferring, it is necessary to contact us with the current customer information and the customer information of the transferee by the method specified by us.

### 3. Validity period

- This software can be used for Validity period (described above) from the date when the purchased license key is activated. After the expiration date, the software will no longer be usable.
- If you want to continue using it after the expiration date, you will need to renew your license.
- If you do not renew your license and want to discontinue use, you must destroy all copy of the software.

### 4. Support

- Support for this software will only be provided by email. We will do our best to respond as soon as possible, but depending on the content, we may not be able to respond sufficiently. Acceptable language is English and Japanese. For other languages we use software translations and may not be accurate.
- We will provide free support within the validity period of the license.
- We will provide the latest version of the software free of charge within the validity period of the license.

### 5. Warranty

- This software is not guaranteed to work on all personal computers released now and in the future.
- This software is designed and manufactured to ensure that data is erased in various situations, but we do not guarantee 100% erasure.
- Our liability for direct or indirect damages incurred by the customer or a third party due to the use or inability to use this software is limited to the price of this software in any case including software defects.
- If there is a serious problem with this software, we will provide a update version. However, we will decide the timing, contents, necessity, etc.

### 6. Copyright

All copyrights relating to this software, documents, accompanying images, and their reproductions belong to us, except for the parts used under the GPL license.

### 7. Termination

- This agreement automatically terminates when the valid license period expires.
- If you breaches any material term of this agreement, this agreement can be terminated by giving notice. You are requested to discontinue use of this software, return or discard the all copy of the software.
- If you wish to terminate this Agreement, you may terminate this Agreement with a written request to us. You are requested to discontinue use of this software, return or discard the all copy of the software. In that case, the price will not be returned.
